Approval of Minutes

General Business:

Parent Student Handbook

- The Board discussed the content of the Parent Student Handbook as a whole. It had been reviewed previously by members before the meeting.
- **Motion was made by Steve Liu to approve the Parent Student Handbook content.**

Vote was 5-0 in favor to approve content of the Parent Student Handbook.

Employee Manual

- The Board discussed the content of the employee manual as a whole. It had been reviewed previously by members before the meeting. There was discussion of a few minor edits (typos, formatting).
- **Motion was made by Steve Liu to approve the Employee Manual content, with the few minor changes discussed.**

Security Task Force

- Report was given by Steve Sherman of the proposal to form a Security Task Force. There was a discussion in terms of length of term of the members, as well as legal ramifications of the Task Force. A few small changes were made to the proposal (legal ramifications)
- **Motion was made by Todd Pierce to approve the formation of the Security Task Force as proposed with the additional changes discussed. Steve Sherman seconded the motion. Vote was 6-0 in favor of forming the Security Task Force.**

Board Policy Manual

- The Board Policy Manual was previously sent out and reviewed by Board members before the meeting and each section was discussed briefly in terms of any edits or changes.
- Section 100: Vision Statement: “enviable” should be replaced with “exceptional” to coincide with the previously revised statement
- Section 100: Statement of Faith: The previously amended statement needs to be added. Specifically, the last point on the unique roles of male and female.
- No changes for sections: 200, 300, 400, 500, 600, 700, 800, 900, or 1000.
- **Motion was made by Kristi Rotzoll for blanket approval of the Policy Manual with the above noted changes. Todd Pierce seconded the motion. No further discussion. Vote was 6-0 in favor.**

There was a brief discussion on logistics for the upcoming Open House and Parent Orientation Night.
